TO: Hamilton County Drainage Board

RE: Fitch & Jessup Drain Maintenance Assessment Increase

At this time I recommend that the rates for the maintenance assessment for the Fitch & Jessup Drain be revised. Currently the rates for this drain are set at \$1.00 per acre with a \$5.00 minimum, and \$10.00 per acre for roads. With 314.39 acres and 264 lots in the drainage shed the annual assessment for this drain is \$2,583.12. The fund is currently in the red \$15,453.70. Currently there are no open drainage complaints and eight (8) outstanding work orders issued.

At its meeting of September 23, 2013 the Board had tabled a previous request to increase the assessment rates due to remonstrance (See Hamilton County Drainage Board Minutes Book 15, pages 178-183). Per my report at that time dated August 2, 2013 the proposed rates were as follows:

1. Maintenance assessment for agricultural tracts be set at \$5.00 per acre with a \$25.00 minimum.
2. Maintenance assessment for non-platted residential tracts be set at \$5.00 per acre with a \$25.00 minimum.
3. Maintenance assessments for platted lots in subdivisions whose drainage systems will not be part of the regulated drain shall be set at \$45.00 per lot/minimum. Common areas within the non-regulated drain subdivisions shall be assessed at \$10.00 per acre with a \$45.00 minimum.
4. Maintenance assessment for platted lots within subdivisions whose drainage system will be part of the regulated drain shall be set at \$65.00 per lot/minimum. Common areas within the regulated drain subdivisions shall be set at \$15.00 per acre with a \$65.00 minimum.
5. Maintenance assessment for commercial, institutional and multi-family residential tracts to be set at \$15.00 per acre with a \$85.00 minimum.
6. Maintenance assessment for roads and streets be set at \$15.00 per acre:

With the proposed rates listed above the annual collections would have been \$16,639.32.

I recommend the rates be revised to the following rates.


1. Maintenance assessment for agricultural tracts be set at \$3.00 per acre with a \$15.00 minimum.
2. Maintenance assessment for non-platted residential tracts be set at \$3.00 per acre with a \$15.00 minimum.
3. Maintenance assessments for platted lots in subdivisions whose drainage systems will not be part of the regulated drain shall be set at \$35.00 per lot/minimum. Common areas within the non-regulated drain subdivisions shall be assessed at \$5.00 per acre with a \$35.00 minimum.
4. Maintenance assessment for platted lots within subdivisions whose drainage system will be part of the regulated drain shall be set at \$65.00 per lot/minimum. Common areas within the regulated drain subdivisions shall be set at \$10.00 per acre with a \$65.00 minimum.
5. Maintenance assessment for commercial, institutional and multi-family residential tracts to be set at \$10.00 per acre with a \$75.00 minimum.
6. Maintenance assessment for roads and streets be set at \$10.00 per acre.

With above rates the drain will collect \$12,601.18 annually. These collections at the revised rates will begin in May 2017.

I further recommend to the Board that the drain maintenance assessment collections be extended from four (4) times the annual collection to eight (8) times the annual collections as allowed in IC 36-9-27-43.

I recommend the Board set a hearing for this matter on November 28, 2016.

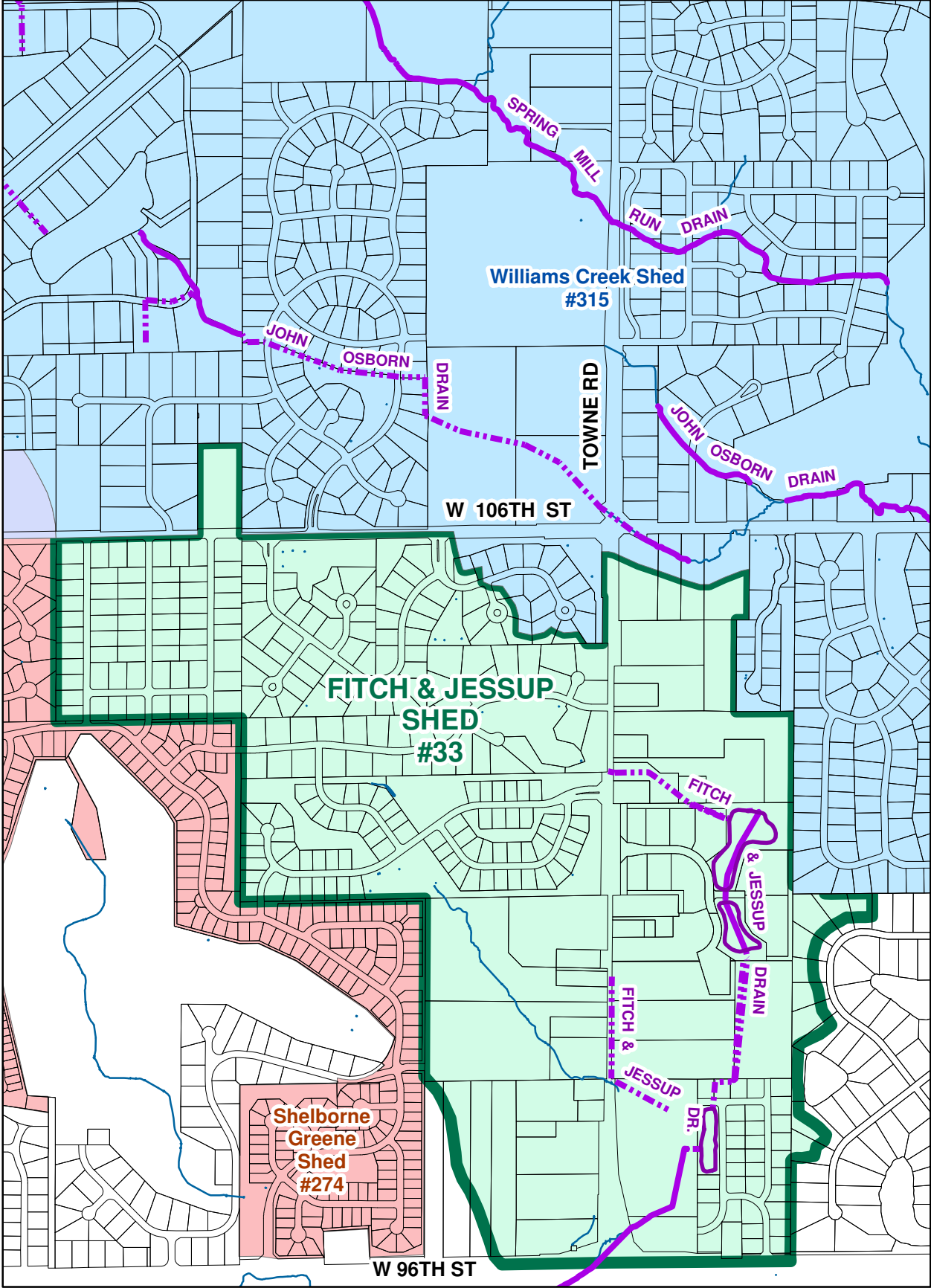
