Re: Mallery-Granger Drain

Attached are a drain map, watershed map and schedule of assessments for the Mallery-Granger Drain. This drain is presently number five (5) on the 2012 Drain Classification List for reconstruction.

The Mallery-Granger Drain shall consist of the Mallery-Granger Drain, Mallery-Granger Drain, North Arm, Mallery-Granger Drain, Feather Cove Arm and the Mallery-Granger Drain, John Deer Arm. These drains are located in Noblesville and Jackson Townships.

The Mallery-Granger Drain was constructed by order of the Hamilton County Circuit Court in 1881. (Order Book 4, pages 545-553). The original drain consisted of a main drain and three (3) arms. Over the years since originally constructed the drain was altered several times. The first was by the construction of the Indiana Filler Drain constructed in 1915 which replaced Arm 2 of the drain. The second was in 1928-1930 when the construction of the County-McMahon Drain replaced the first 663 feet of the main drain and Arm 3. The Mallery-Granger Drain was dredged by order of the Hamilton County Commissioners in 1917. The drain was last dredged in 1955 by order of the Hamilton County Circuit Court. At that time the main drain began at the east side of the Nickel Plate Railroad at Sta. 18+69. The open ditch between Sta. 6+63 and this point at some point in time became part of the County-McMahon Drain. The drain today consists of the main drain from Sta. 18+69 to Sta. 66+00 (4,731 feet) and Arm 1 from Sta. 0 to Sta. 88+30 (8,830 feet). The drain consists of 13,561 feet of open ditch.

The Mallery-Granger Drain, North Arm was petitioned by the City of Noblesville. The drain was described in my revised report to the Board dated June 7, 1999 and approved by the Board on June 28, 1999 (see Hamilton County Drainage Board Minutes Book 5, page 169 to 172). The drain consists of 2,230 feet of open ditch.

The Feather Cover Arm of the Mallery-Granger Drain was petitioned by Community Development II, Inc. The drain was outlined in my report dated July 14, 2000 and was approved by the Board at hearing on August 28, 2000 (see Hamilton County Drainage Board Minute Book 5, pages 423-425). The drain consists of 9,355 feet of storm sewer and 560 feet of open ditch for a total of 9,915 feet of drain.

The John Deer Arm of the Mallery-Granger Drain was petitioned by Morse Lake Industrial Park, LLC to regulate a portion of open drain along the east property lines of Tract 11-06-24-00-00-024.000 and Tract 11-06-24-00-00-024.002. This open drain outlets into the existing Feather Cove Arm of the Mallery-Granger Drain and is described in my report to the Board dated March 18, 2005 and approved by the Board at hearing on May 23, 2005 (see Hamilton County Drainage Board Minutes Book 8, pages 316-317). The total length of the drain is 630 feet of open ditch.

The office has had three (3) complaints on the portion of the ditch not on maintenance since 2004. Those are as follows:

Although the Mallery-Granger Drain is on the reconstruction list, I am recommending that it be placed on maintenance at this time. The drain shall remain on the reconstruction list until plans can be finalized and a reconstruction hearing held to reconstruct the drain. By placing the drain on maintenance at this time when the reconstruction plans are prepared the Board can utilize up to 75% of that fund under IC 36-9-27-45.5 to offset reconstruction costs.

At this time the open ditch is heavily overgrown and is in need of clearing. The drain is susceptible to jams caused by debris which causes backwater and localized flooding. It is possible for large woody debris to collect on road crossings. This creates a threat to the bridge/culvert structure and can redirect flow causing erosion.

The nature of maintenance work is as follows:

1. Clearing of trees and brush on the existing open ditch;
2. Creation of or re-excavation of silt basins;
3. Re-excavation of open ditch to original grade line;
4. Surface water structures as might be required;
5. Removal of beaver dams;
6. Bank erosion protection and/or seeding as might be required;
7. Repair of bank erosion;
8. Repair of private tile outlet ends as might be required;
9. Repair of regulated drain tile outlets;
10. Repair of broken tile on regulated drains;

11. Installation of breather pipes on regulated drains as might be required;
12. Removal of debris and/or blockage from regulated tile and open ditch;
13. Cleaning and/or repair of existing catch basin as might be required;
14. Removal of trees and or tree roots blocking storm sewers or tiles;
15. Spraying for vegetation control;
16. Mowing filter strips;
17. Any other repairs deemed to be applicable and necessary by the Surveyor to restore the drain to its original intended use and condition.

The frequency with which maintenance work should be performed is annually as required by the condition of the drain.

Currently there are three (3) arms of the Mallery-Granger Drain that are under maintenance. They are the Mallery-Granger Drain, North Arm, Mallery-Granger Drain, Feather Cove Arm and the Mallery-Granger Drain, John Deer Arm.

At this time portions of the Mallery-Granger Drainage Shed is assessed for maintenance. The Mallery-Granger North Arm was placed on maintenance when it was established at the June 28, 1999 hearing that was mentioned above. The rates established for this drainage shed is \$3.00 per acre with a \$15.00 minimum.

The Feather Cove Arm was placed on maintenance when it was established at the August 28, 2000 hearing mentioned above. The rates established at that time was \$10.00 per acre for roadways, \$10.00 per acre for common areas and a \$75.00 per lot/minimum assessment.

The John Deer Arm was placed on maintenance when established at the May 23, 2005 hearing mentioned above. The rate established at that time was for commercial tracts at \$10.00 per acre with a \$75.00 minimum.

All three arms have different rates established. The current lands which are assessed amount to 189.91 acres and 61 lots. The current annual assessment is \$5,769.70 and has a current balance in the fund of \$85,937.02.

I have reviewed the plans and drain map and after considering the criteria as set out in IC 36-9-27-112 believe that all tracts within the drainage shed of the Mallery-Granger Drain will benefit equally as per land use. I recommend the following maintenance assessment to be adopted by the Board:

1. Maintenance assessment for agricultural tracts be set at \$4.00 per acre with a \$15.00 minimum.
2. Maintenance assessment for non-platted residential tracts be set at \$4.00 per acre with a \$15.00 minimum.

3. Maintenance assessment for commercial, institutional and multi-family residential tracts to be set at \$10.00 per acre with a \$75.00 minimum.
4. Maintenance assessment for platted lots in subdivisions whose drainage systems will not be part of the regulated drain shall be set at \$35.00 per lot/minimum. Common areas within non-regulated drain subdivisions shall be assessed at \$5.00 per acre with a \$35.00 minimum.
5. Maintenance assessment for platted lots in subdivisions whose drainage system will be part of the regulated drain shall be set at \$65.00 per lot/minimum. Common areas within the regulated drain subdivisions shall be set at \$10.00 per acre with a \$65.00 minimum.
6. Maintenance assessment for roads and streets to be set at \$10.00 per acre.

The drainage shed for the Mallery-Granger Drain consists of 1,127.85 acres and 248 lots. The total annual maintenance assessment for the drain will be \$19,155.52. The period of collection shall be eight (8) years as per IC 36-9-27-43.

The current maintenance drainage fund for the Mallery-Granger Drain (#313) shall remain in effect. The new assessments shall be placed within the existing fund.

Although not specifically noted in the NPDES Phase II General Permit Application, Storm Water Quality Management Plan Part C: Program Implementation Report, The Mallery-Granger Drain is within the drainage shed for the White River which is identified on Page 2 of the report as an MS4 receiving stream.

The Mallery-Granger Drain is mentioned in the NPDES Phase II General Permit Application Storm Water Quality Management Plan Part B: Baseline Characterization Report. The drain is listed on the following pages of this report:

- Page 7 as #05120201070030 Watershed within the MS4 Area.
- Page 16 as being an impaired waterbody due to E. Coli.
- Page 32 as being a priority watershed.
- Page 44 as being a priority watershed due to multiple impairments and as a recreational watershed.

This drain is listed on the 2012 303(d) List of Impaired Waters for Indiana on pages 130 and 246. The impairment listed is for E. Coli.

I recommend the Board set a hearing for this proposed drain for November 26, 2012.

The Mallery Granger Main Ditch and it's following tributaries, County McMahan, North and South Arms were walked on Tuesday, April 7, 2011.

Mallery Granger - Main Ditch

The main ditch from 196th Street to 216th Street is overgrown, woolly and in need of clearing. There a few areas along this stretch of ditch that the property owners have removed vegetation from the ditch and do maintain the drain across the property. The ditch has good definition and fall from 196th Street to James Road. There are several washed or eroded areas along the drain through this area that need to be addressed. The drain northwest of James Road starting at the pipeline crossing starts to narrow and appears to be obstructed with a heavy load of sediment, cattails and other debris.

County McMahan Arm

The open ditch from State Road 19 across the old peat bog property to the railroad is in need of maintenance. The open ditch west of the railroad across James Road to the main ditch has very little definition, is overgrown and has a lot of dead fall in the flowline. The peat bog continues to pump water from their site into the drain when needed.

Mallery Granger - North Arm

The open ditch east of Hague Road to the main ditch is in decent shape. There is a small section of cattails east of Hague Road next to Lingenfelter's that need to be removed from the flowline of the drain.

Mallery Granger – South/Feathercove Arms

This section of drain was petitioned several years ago and was never acted on. The drain was to provide an outlet for the Steckley pond on the west side of Hague Road. The water from the pond now slobbers out of the pond through a washed notch to an existing CMP pipe under Hague Road where it then travels south along the east side of Hague Road in the sideditch to a shallow swale on the Hague Road Storage property. The water than turns and travels east in the swale between the Cruzan and Storage properties and continues along the properties where it goes into a wooded area east of the Storage and Landscape properties. The area is overgrown and is in need of a defined channel. The water slobbers across the surface until it enters a slight defined channel east of the Feathercove outlet. The channel picks up definition as it progresses toward the main ditch but is overgrown.


