Re: Cool Creek Drain – Foster Estates, Danbury Estates, and Laura Vista Maintenance Assessment Area

Attached is a drain map, drainage shed map and schedule of assessments for maintenance for Cool Creek Drain. This watershed area to be assessed is located in Clay and Washington Townships from Keystone Avenue to east of Carey Road.

Cool Creek and several arms have been previously placed on a maintenance program over the last 5 years. This portion of the Cool Creek Drain consists of the Cool Creek Drain – Foster Estates Extension, Danbury Estates Extension, and Laura Vista Extension. The Cool Creek Drain – Foster Estates Extension was established per my report dated August 20, 2009 and approved by the Board at a hearing on September 28, 2009 (see Hamilton County Drainage Board Minutes Book 12, Pages 252 to 254). The Danbury Estates Extension was established per my report dated March 31, 2010 and approved by the Board at a hearing on May 24, 2010 (see Hamilton County Drainage Board Minutes Book 12, Pages 549 to 550). The Laura Vista Extension was established per my report dated August 20, 2009 and approved by the Board at a hearing on September 28, 2009 (see Hamilton County Drainage Board Minutes Book 12, Pages 239 to 240). This consists of 2,755 feet of open ditch to be maintained.

At this time Cool Creek Drain is listed on the proposed 2012 Classification List for reconstruction at number 9. The drain was requested for classification by Paul Wheeler on January 15, 1971, Bruce O. Butts on June 7, 1979 and J. Donald Day on May 9, 2005. The office has had twenty-three (23) complaints on the drain since 2002. Those are as follows:

Although this drain is on the reconstruction list, I recommend that this drain be placed on maintenance. The upper portion of the drain was reconstructed in 2007 – 2008 per my report dated April 9, 2007 and approved at hearing on July 9, 2007 (see Hamilton County Drainage Board Minutes Book 10, pages 345 – 350). Any additional portions of the drain needing reconstruction should be petitioned for in the future.

The nature of maintenance work required is as follows:

1. Clearing of trees and brush on the existing open drain as needed to improve flow;
2. Creation and re-excavation of silt basins;

3. Re-excavation of open ditch to original grade line;
4. Surface water structure as might be required;
5. Bank erosion protection and/or seeding as might be required;
6. Repair of private tile outlet ends as might be required;
7. Repair of regulated drain tile outlets;
8. Removal of beaver dams;
9. Removal of debris and/or blockage from regulated open ditch;
10. Cleaning and/or repair of existing catch basin as might be required;
11. Spraying for vegetation control;
12. Mowing filter strips;
13. Any other repairs deemed to be applicable and necessary by the Surveyor to restore the drain to its original intended use and condition.

The frequency with which maintenance work should be performed is annually as required by the original condition of the drain.

A Watershed Management Plan was prepared by Clark Dietz Engineers in 2003. The plan was updated through a 319 Grant in 2005. This report provided recommendations to the Drainage Board for maintenance, reconstruction and flood control.

I have reviewed the plans and drain map and believe, as set out in IC 36-9-27-69(b) (1) that all tracts within the drainage shed of the Cool Creek Drain will benefit. The following maintenance assessment has been adopted by the Board:

1. Maintenance assessment for roads and streets be set at \$10.00 per acre with a \$25.00 minimum.
2. Maintenance assessment for agricultural tracts be set at \$2.00 per acre with a \$15.00 minimum.
3. Maintenance assessment for non-platted residential tracts be set at \$2.00 per acre with a \$15.00 minimum.
4. Maintenance assessment for commercial, institutional and multi-family residential tracts to be set at \$35.00 per acre with a \$75.00 minimum.
5. Maintenance assessment for platted lots in subdivisions whose drainage systems will not be part of the regulated drain (those systems maintained by the City of Westfield) shall be set at \$25.00 per lot - \$25.00 minimum. Commons areas within subdivisions whose drainage systems will not be part of the regulated drain (those systems maintained by the City of Westfield) shall be set at \$10.00 per acre with a \$25.00 minimum.

6. Maintenance assessment for platted lots within subdivisions whose drainage system will be part of the regulated drain shall be set at \$15.00 per acre with a \$65.00 minimum. Common areas within regulated drain subdivisions shall be set at \$15.00 per acre with a \$65.00 minimum.

The annual maintenance collection for this extension will be \$16,717.50.

This drain has been classified as an urban drain under IC 36-9-27-67 per my report dated April 9, 2007.

Cool Creek has been identified in the NPDES Phase II General Permit Application, Storm Water Quality Management Plan Part C: Program Implementation Report, page 3, as a MS4 area receiving stream.

Cool Creek is listed in the NPDES Phase II General Permit Application Storm Water Quality Management Plan Part B: Baseline Characterization Report on the following pages:

Page 3 as an MS4 Area Receiving Stream

Page 6 as #05120201090030 Watershed within the MS4 Area

Page 14 as being in the IDEM 305(b) Report as being fully supportive of aquatic life and full body contact

Page 16 as not substantially impacted by MS4 storm water discharges



This drain is listed on the 2008 303(d) list of impaired waters for Indiana. The parameter of concern is E.Coli.

Currently the open ditch is heavily overgrown and is in need of select clearing. The drain is susceptible to jams caused by debris which causes backwater and localized flooding. It is possible for large woody debris to collect on road crossings. This creates a threat to the bridge structure and can redirect flow causing erosion. This drain has had a large beaver population.

I recommend that the Board set a hearing for this proposed maintenance for November 26, 2012.


