BOARD MEETING INFORMATION AND GUIDELINES

Hamilton County Parks and Recreation Board meetings are generally held on the 3rd Monday of each month at 6:00 pm. Board meetings are held at the Hamilton County Parks and Recreation Administration Office located at 400 Lafayette Road, Noblesville, IN 46060. These days, times, and locations are subject to change with proper notice posted in compliance with Indiana law. Please contact the Parks and Recreation Administration Office if you have questions or wish to verify meeting information.

All regular board meeting, special board meetings, and emergency board meetings are open to the public. Closed executive sessions are held for the purpose of discussion as permitted by IC 5-14.1.5-6.1(b)(1). No official action may be taken in executive session. All board action must be made during public session.

General Information Regarding Public Input

There is no legal requirement that the public be given the opportunity to speak at board meetings. If the pressure of business or other circumstances dictate, the board President may decide to curtail this practice.

Individuals wishing to address the board must have signed in at least five minutes prior to the start of the board meeting. The sign-in sheets will be available near the entry door in the room where the board meeting will be held. An individual must list his/her name, home address, and topic to be discussed.

At the beginning of the regularly scheduled board meeting, comments may be accepted from those individuals who signed in prior to the start of the board meeting.

Upon recognition by the board president, the individual should state his/her full name, home address, and the reason for wishing to speak. Each person will be given three minutes to address the board with comments related to the business of the board. A maximum of thirty minutes will be allowed for public input.

Interruptions or interference with the orderly business of the board will not be allowed. The presiding officer may terminate the speaker's privilege to speak if, after being called to order, the speaker persists in improper conduct or remarks.
